Chronology of Bank "Revival"

The Bank was founded in 1991.

In 1992 he obtained a license of Bank of Russia foreign currency, the bank became a member of the Moscow Interbank Currency Exchange. Bank shares started trading on Russian exchanges.

In 1997, the bank's ADR began trading on international stock markets.

1998 - launch of the processing center (independent issue plastic cards). Creation of ATM infrastructure.

December 9, 2004 Bank "Revival" was included in the register of banks - participants of the deposit insurance system under number 276.

In 2007, the millionth bank card. Also in 2007, it carried out the 20th issue of shares.

In October 2013 among the depositors of the bank in some areas of the Moscow region a panic because of the SMS-mailings and telephoned, reported the imminent withdrawal of the license of the bank. The initiator of the attack information is not found.

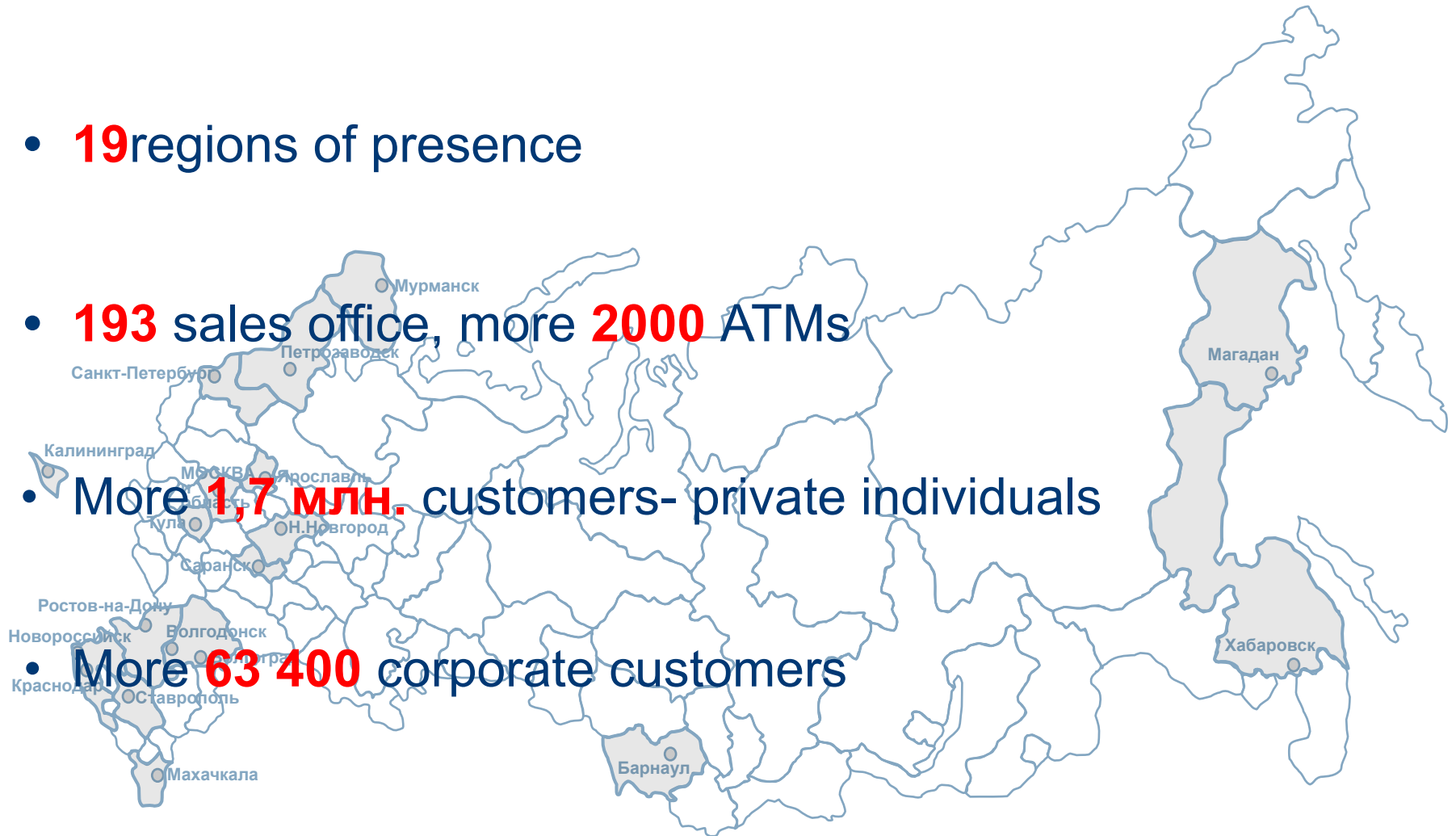
