Annual data are updated in April and in July of each year, and broken down by commodity group and selected origin and destination in August. Quarterly data are updated every 2 weeks and monthly data are updated daily.

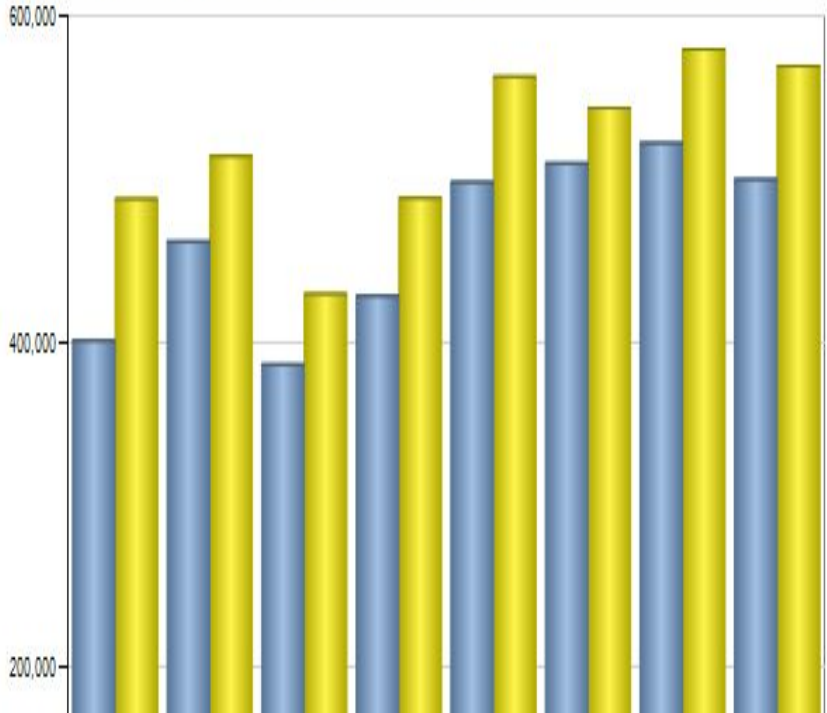

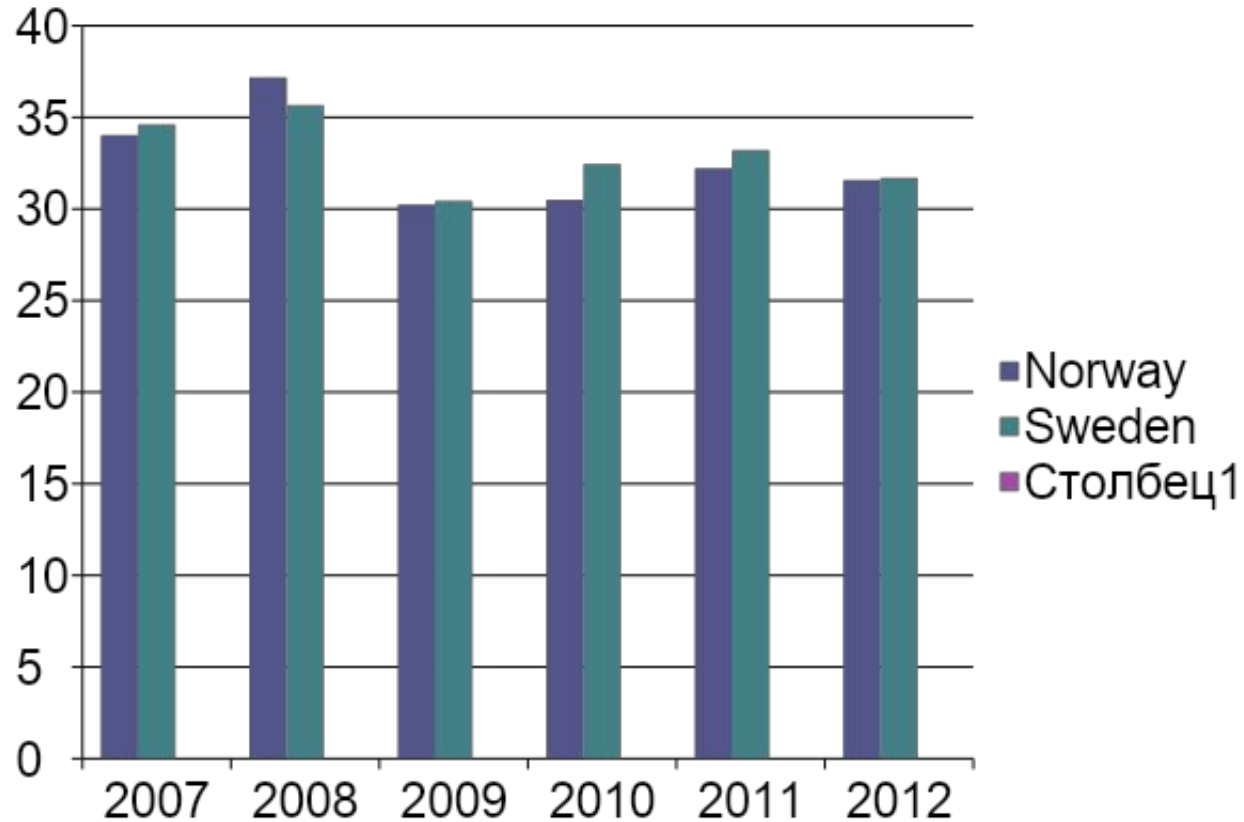

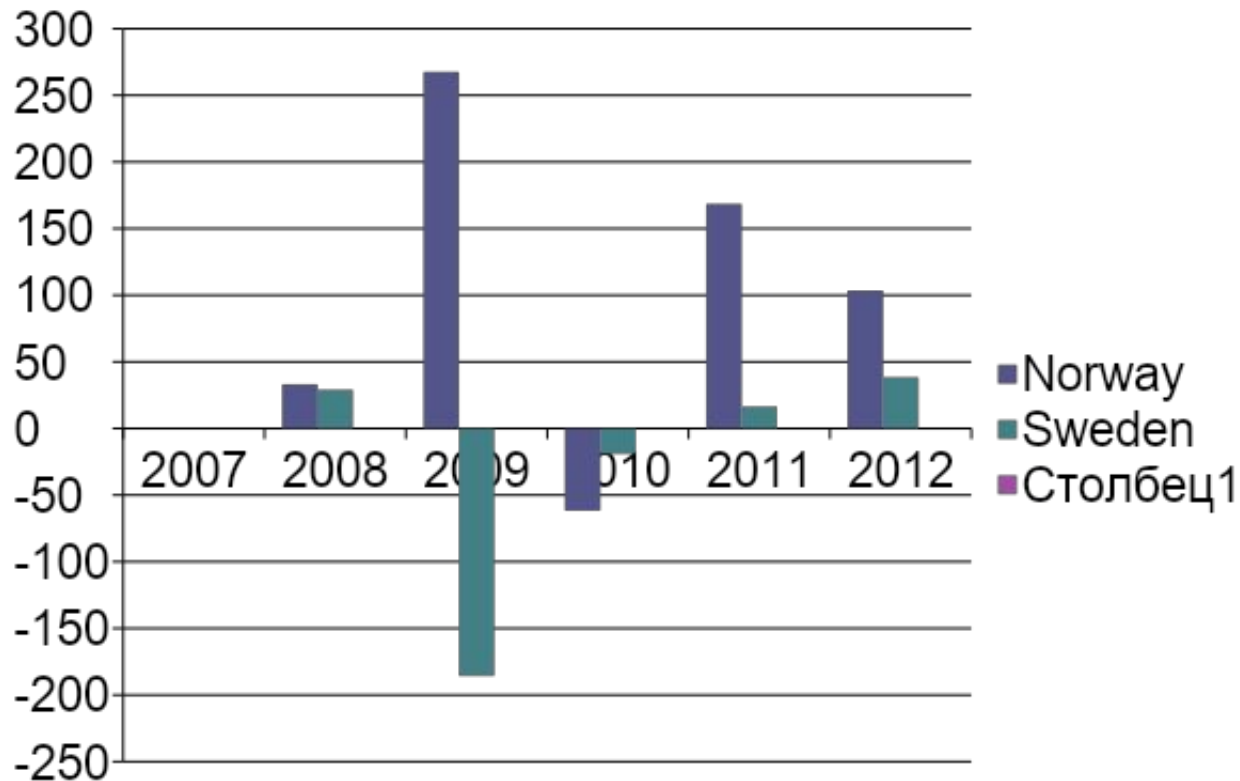

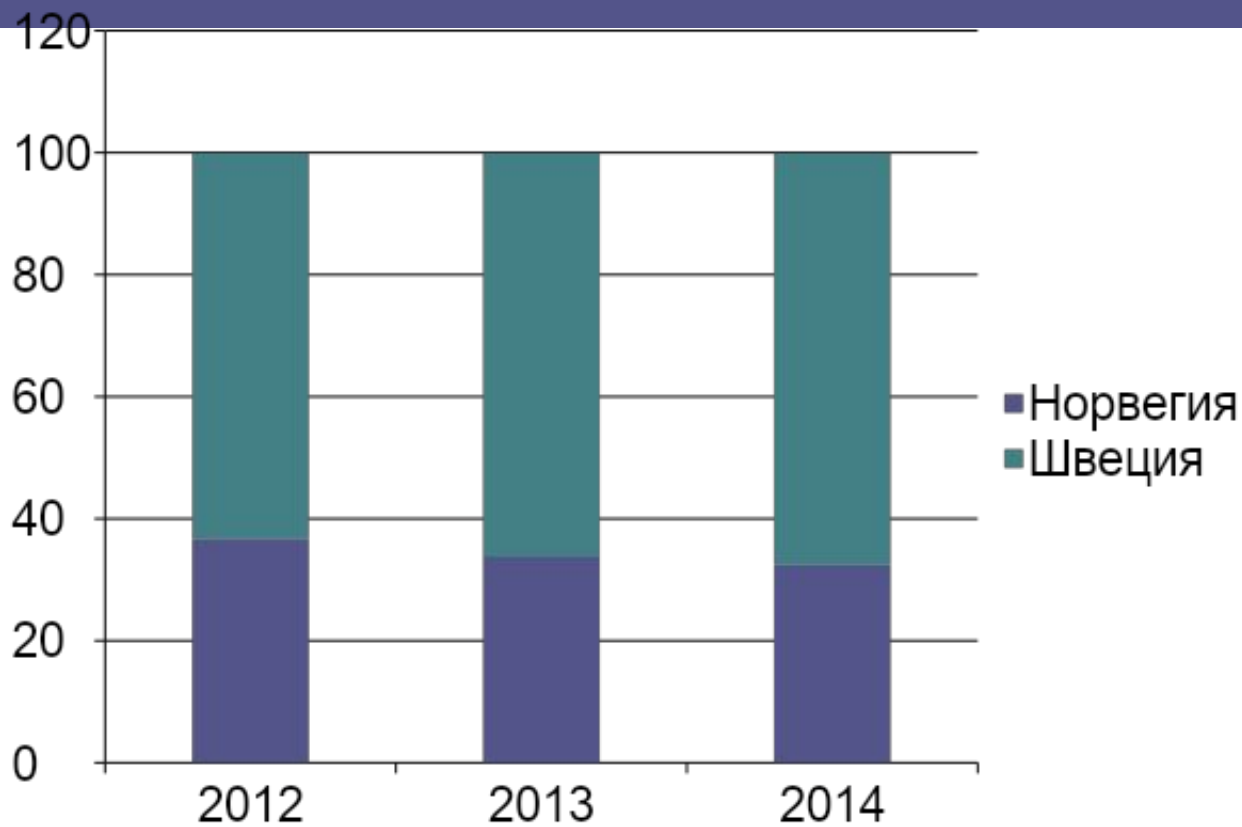

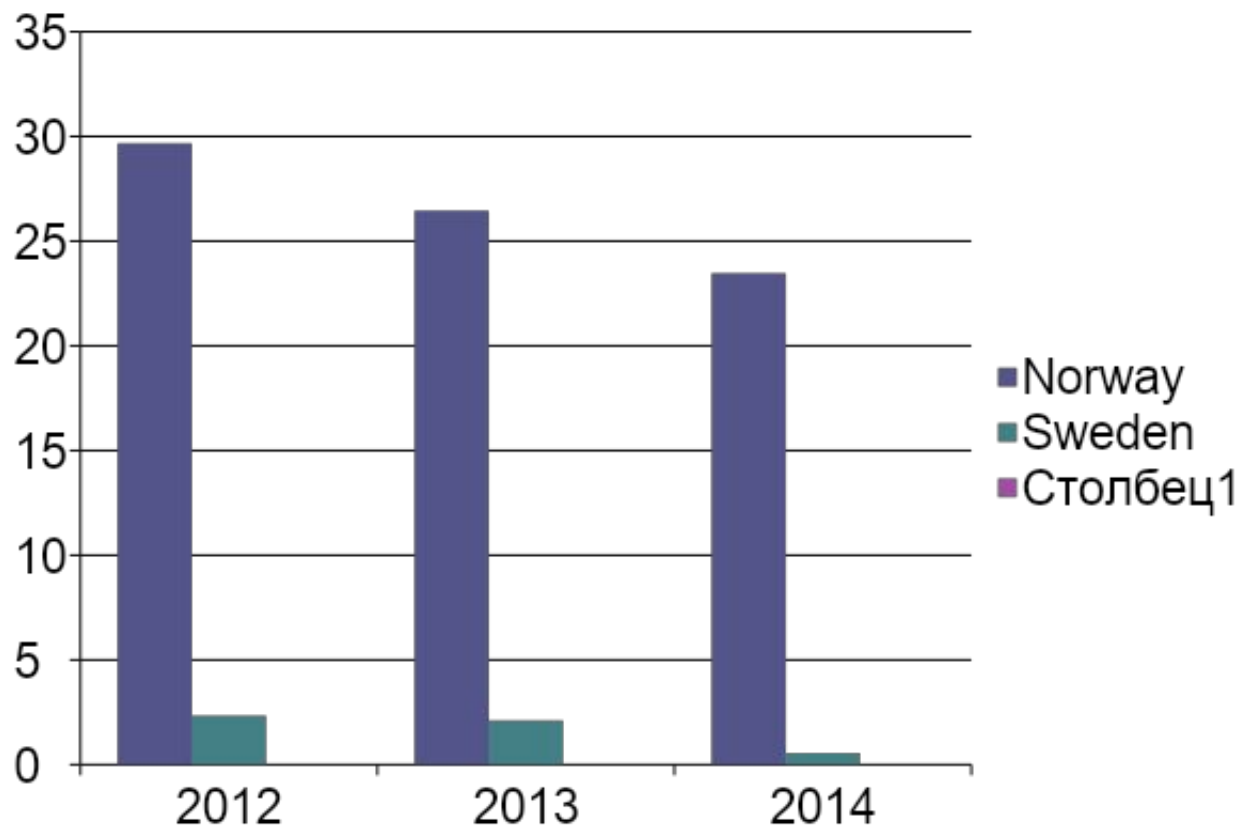

# Выводы

- 1. Швеция, экспортирующая примерно 50% своего производства, более вовлечена в международную торговлю, чем Норвегия, однако и более зависима от международных рынков.
  2. Экономика Швеции более открыта для международной торговли, об этом говорит импортная квота, колеблющаяся на уровне 50-55%, опять же, это обуславливает зависимость от импортной продукции.
  3. Коэффициент опережения темпами роста экспорта темпов роста ВВП у Норвегии во много раз больше, поэтому Норвегия более вовлечена в МРТ, чем Швеция.
  4. Коэффициент внутриотраслевой международной специализации показывает, что Швеция более склонна к импорту, чем Норвегия.
