- Federal bailiff service (FSSP Russia) is a Federal Executive authority performing functions on provision of the established order of activity of courts, enforcement of judicial acts, acts of other bodies and officials, as well as enforcement functions and functions on control and supervision in the established sphere of activities. Functions and Service tasks

- The Federal bailiff service is a Federal Executive authority and performs functions to ensure the established order of activity of courts, enforcement of judicial acts, acts of other bodies and officials, as well as enforcement functions and functions on control and supervision in the established sphere of activities.

Functions and Service tasks

- The main objectives of the FSSP of Russia are:
 - 1) ensuring the established procedure of activities of the constitutional Court of the Russian Federation, the Supreme Court of the Russian Federation, the Supreme Arbitration Court of the Russian Federation, courts of General jurisdiction and arbitration courts;
 - 2) the organization of compulsory execution of judicial acts of courts of General jurisdiction and arbitration courts and acts of other bodies, stipulated by the legislation of the Russian Federation on enforcement proceedings;
 - 3) the implementation of the legislation on criminal proceedings in cases within the criminal procedural legislation of the Russian Federation to the investigative jurisdiction of the Federal court bailiffs service;
 - 4) management of territorial bodies FSSP of Russia.

Functions and Service tasks

- Federal bailiff service of Russia in its activity is guided by Constitution of Russian Federation, Federal constitutional laws, Federal laws, acts of the President of the Russian Federation and the Government of the Russian Federation, international treaties of the Russian Federation, acts of the Ministry of justice.

Functions and Service tasks

- Federal bailiff service of Russia in the extent of competence:
 - provides the established order of court activities;
 - provides Executive production on compulsory enforcement of judicial acts, acts of other bodies and officials;
 - apply measures of compulsory execution on the basis of the Executive document;
 - evaluates and records of the arrested and withdrawn property;
 - organizes storage and enforcement of the arrested and withdrawn property;
 - carries out search of the debtor organization and property of the debtor (citizen or organisation);
 - participates in protection of interests of the Russian Federation as creditor in Affairs about bankruptcy and in procedures of bankruptcy;
 - performs other actions necessary for timely, complete and correct execution of Executive documents.

Department of organization of enforcement proceedings

Main tasks of the Department of organization of enforcement proceedings is implementation of the state policy in the established sphere of activities through the organization of work of territorial bodies FSSP of Russia for timely and actual execution of judicial acts and acts of other competent authorities, the implementation of the established forecast and key performance indicators for the Executive production, provision of legitimate rights of citizens and legal entities, as well as improvement of the current legislation in the sphere of activities of the Federal bailiff service of Russia and departmental regulatory framework.

ПОЛОЖЕНИЕ

об Управлении организации работы по реализации имущества должников
Федеральной службы судебных приставов

I. Общие положения

1.1. Управление организации работы по реализации имущества должников ФССП России (далее – Управление) является структурным подразделением центрального аппарата ФССП России.

1.2. Управление в своей деятельности руководствуется Конституцией Российской Федерации, федеральными конституционными законами, федеральными законами, актами Президента Российской Федерации и Правительства Российской Федерации, международными договорами Российской Федерации, правовыми актами Минюста России и ФССП России, а также настоящим Положением

1.3. В Управлении для выполнения возложенных на него задач создаются отделы.

1.4. Предложения о внесении изменений в структуру и штатное расписание центрального аппарата ФССП России в части, касающейся Управления, представляются в установленном порядке.

1.5. Компетенция Управления определяется приказами и распоряжениями ФССП России, а также Положением об Управлении.

1.6. Управление осуществляет свою деятельность как самостоятельно, так и во взаимодействии с другими структурными подразделениями центрального аппарата ФССП России и ее территориальными органами.

1.7. Основными задачами Управления являются:

1.7.1. Обеспечение проведения оценки и учета арестованного и изъятого имущества.

1.7.2. Организация хранения и принудительной реализации арестованного и изъятого имущества.

1.7.3. Организация розыска должника, его имущества или розыска ребенка.
